9.b. Peer Review on Energy Efficiency (PREE) and Cooperative Energy Efficiency Design for Sustainability (CEEDS)

- To provide a broad review of EE goals, EE strategies, institutional setup, and policy measures in all sectors for a volunteer economy;
- To provide recommendations for a volunteer economy based on best/high performance practices in order to implement best practices in as many economies as possible.



- In 2012, the Follow-Up PREE is designed to assist former PREE host economies in implementing the original recommendations of the PREE review teams.
- The objective is to fill the gap between the implementation of energy efficiency action plans and the monitoring and evaluation of those plans.



9.b. (3) 2nd Follow-up PREE (The Philippines)

- In PREE Phase 4, the Philippines hosted the second Follow-up PREE from 15-19 September 2014 on its industry sector (Sugar, Cement, Glass) and commercial buildings.
- The peer review was conducted by a team of eight experts (from Japan, New Zealand, Thailand, USA and APERC).
- The draft final Report is compiled and now presented to this meeting to seek endorsement by EWG.



9.b. (4) Objectives and Activities of CEEDS

Objectives of CEEDS

- To promote "high-performance" energy efficiency policy measures in developing economies in the APEC region.
- To assist developing economies who wish to design and implement measures for achieving energy efficiency improvements in a specified sector.

Activities of CEEDS:

- Analysis / Study on energy saving potential.
- A set of two workshops to study on how the best practice policy measures might be implemented in the selected sector.



9.b. (5) Integration of CEEDS to PREE

- CEEDS was a very complicated project:
- ✓ Two workshops in two different economies.
- ✓ The same participating delegates and expert speakers for both workshops in principle.
- Given the resource constraints of APERC, CEEDS is:
- To be integrated into PREE (i.e. no longer an independent project).
- To be renamed as "Energy Efficiency (EE) Policy Workshop".
- To be held in conjunction with one of the two bi-annual meetings of EGEE&C (Expert Group of Energy Efficiency and Conservation).



9.b. (6) future PREE

- Due to budget constraints, APERC will apply not APEC
 Operational Fund but APEC Support Fund for PREE from its Phase 5.
- Thailand has shown intent to host the 3rd Follow-up PREE if the budget for PREE Phase 5 is approved.
- The 1st "EE Policy Workshop" will be held as a part of PREE Phase 5.
- In order to properly design EE Policy Workshop, APERC is planning to hold a trial EE Policy Workshop as a Self-Funded project in conjunction with EGEE&C 45 in Singapore.
